**Directions for Use:**

To be used only in the manufacture (formulating, repackaging, repouring) of a pest control product solely for export from Canada. Read Technical Bulletin for formulating details. If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
