FIRST AID

DIRECTION FOR USE:

DO NOT apply to any body of water.

1. Flush the tank.
2. Fill with fresh water to cover the bottom of the tank.
3. For a 180 liter tank (40 gal), pour 120 ml (4 oz) of **RV-Boss™ Grey Water Tank Treatment** in the drain of the sink or shower and rinse.
4. When the gray water tank is full due to normal use of RV, flush the tank.

NOTE: Do not use with other products. Use **RV-Boss™ Grey Water Tank Treatment** after each emptying. DO NOT USE IN THE FRESH WATER TANK.
