DIRECTIONS FOR USE:

To be used in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

POTENTIAL SKIN SENSITIZER.

WARNING POISON

Strictly observe all precautions for handling and using pesticides.

Do not get into eyes, on skin or on clothing. Wash concentrate from skin or eyes immediately. Do not inhale spray mist.

Wear protective goggles when handling. After use wash hands and other exposed skin.

ENVIRONMENTAL PRECAUTIONS:

Toxic to aquatic organisms and non-target terrestrial plants.

Do not contaminate aquatic systems by disposal of waste or cleaning equipment.

FIRST AID:

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

In case of Inhalation: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
