NOTICE TO USER

FIRST AID

DEUCE™ II ADJUVANT is an emulsifiable oil product. It is designed for use as a spray tank adjuvant only for use with ACE® HERBICIDE or ACE II HERBICIDE for post emergent control of grasses in spring wheat and barley.

DIRECTIONS FOR USE

CROPS: Spring Wheat and Barley

DEUCE II ADJUVANT is to be used only with ACE HERBICIDE or ACE II HERBICIDE. Apply at a rate of 0.7 litres per hectare (0.7 L/ha).
