FIRST AID

#### **Use Restrictions**

DO NOT apply directly to treated, finished drinking water reservoirs or drinking water receptacles when the water is intended for human consumption.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

#### MOSQUITOES

Habitat: Standing Water

Irrigation ditches, roadside ditches, flood water, standing ponds, woodland pools, snow melt pools, pastures, catch basins, storm water retention areas, tidal water, and salt marshes. \*Use higher rates in deep and/or polluted water, and when late 3rd and 4th instar larvae predominate.

## \* Post-flood Applications

Use 5.6 - 11.2 kg/ha when dense populations of early 4th instar larvae are present, water contains an abundance of algae or organic matter, and/or local experience suggests the need for higher rates. Re-treat as needed based on local conditions.

Use 1.4-5.5 kg/ha when populations of mosquito larvae are low, water contains small amounts of algae or organic matter, and/or local experience suggests a reduced need for high rates but still requires population control.

## \* Pre-flood Applications

VectoBac FG+ can be applied prior to flooding of mosquito larval habitats. Use 11.2 - 22.4 kg/ ha when up to 7 days pre-flood capacity is needed. Use 22.4 kg/ha when a 7–14 day pre-flood ap-plication is needed. Retreat as needed. Consult your local Valent BioSciences representative for further advice on pre-flood applications with VectoBac FG+.

Apply uniformly by aerial or ground conventional equipment. Avoiding drift at the application

#### <u>Aerial Application</u> <u>Aerial Application Instructions:</u>

Apply only by fixed-wing or rotary aircraft equipment that has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label.

Label rates, conditions and precautions are product-specific. Apply only at the rate recommended for aerial application on this label. Where no rate for aerial application appears for the specific use, this product cannot be applied by any type of aerial equipment. Ensure uniform application. To avoid streaked, uneven or overlapped application, use appropriate marking devices or a GPS system.

#### **Use Precautions:**

Apply only when meteorological conditions at the treatment site allow for complete and even coverage. Apply only under conditions of good practice specific to aerial application as outlined in the National Aerial Pesticide Application Manual, developed by the Federal/Provincial/Territorial Committee on Pest Management and Pesticides.

#### **Operator Precautions:**

DO NOT allow the pilot to mix product to be loaded onto the aircraft. Loading of premixed product with a closed system is permitted. It is desirable that the pilot have communication capabilities at each treatment site at the time of application.

The field crew and the mixer/loaders must wear the personal protective equipment described in the PRECAUTIONS section of this label. When handlers/loaders use closed systems to load product onto the aircraft, the handler requirement for eye goggles and a NIOSH-approved particulate filtering respirator with any N, R, or P filter for biological products may be waived. When reduced personal protective equipment is worn, the respirator and eye goggles must be immediately available for use in an emergency such as a spill or equipment breakdown.

All personnel on the job site must wash hands and face thoroughly before eating and drinking. Protective clothing must be washed before reuse. Decontaminate aircraft cockpit and vehicle cabs if contamination occurs.

#### **RESISTANCE MANAGEMENT RECOMMENDATIONS:**

For resistance management, please note that VectoBac FG+ Biological Larvicide contains a Group 11 insecticide. Any insect population may contain individuals naturally resistant to VectoBac FG+ Biological Larvicide and other Group 11 insecticides. The resistant individuals

may dominate the insect population if this group of insecticides are used repeatedly in the same site. Other resistance mechanisms that are not linked to site of action but are specific for individual chemicals, such as enhanced metabolism, may also exist. The following appropriate resistance management strategies should be followed to delay insecticide resistance:

- Where possible, rotate the use of VectoBac FG+ Biological Larvicide or other Group 11 insecticides with different groups that control the same pests in a site.
- Insecticide use should be based on an Integrated Pest Management program that includes scouting, record keeping, and considers cultural, biological and other chemical control practices.
- Monitor treated pest populations for resistance development.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance management and/or integrated pest management recommendations for the specific site and pest problems in your area.
