DIRECTIONS FOR USE:

To be used only in the manufacture, formulating or repacking of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Causes irreversible eye damage and skin burns. May be fatal if swallowed or inhaled. Harmful if absorbed through skin. Do not get in eyes, on skin, or on clothing. Do not breathe vapour or spray mist. When handling, wear goggles or face shield and chemical-resistant gloves. Wash hands and face after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing and wash before reuse.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsions may be required.

ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms.

DO NOT discharge effluent containing this product or the biocide produced into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

This product should NOT be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid perchlorate or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent. Do not use or store near heat or open flames.

STORAGE

Store the product in original containers in a well-ventilated, cool, dry and secure area. Store away from food, feed or seed. Keep containers tightly closed.

This product is corrosive to mild steel. Do not store or transport in unlined metal containers.
