## **SAFETY AND HANDLING:**

### PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

FLAMMABLE – Flammable liquid. Keep away from heat/sparks/open flames/hot surfaces. No smoking.

Take precautionary measures against static discharge.

Avoid breathing fumes.

Severely irritating to the eye. DO NOT get in eyes.

May cause drowsiness or dizziness.

Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet.

### PROTECTIVE CLOTHING AND EQUIPMENT

Wear long-sleeved shirt, long pants, and/or a Tyvek suit, goggles or face shield, chemical resistant gloves, and shoes plus socks during handling of Restrain Technical.

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

Users should:

- Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.
- Remove clothing immediately if contaminated. Wash thoroughly and put on clean clothing.
- Remove Personal Protective Equipment (PPE) immediately after handling this product.
- Wash the outside of gloves before removing.
- As soon as possible, wash thoroughly and change into clean clothing.

### **FIRST AID:**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed	<ul style="list-style-type: none"><li>• Call a poison control centre or doctor immediately for treatment advice.</li><li>• Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor.</li><li>• Do not give anything by mouth to an unconscious person.</li></ul>
If in eyes	<ul style="list-style-type: none"><li>• Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first five minutes, then continue rinsing eye.</li><li>• Call a poison control centre or doctor for treatment advice.</li></ul>

If on skin or clothing	<ul style="list-style-type: none"> <li>• Take off contaminated clothing.</li> <li>• Rinse skin immediately with plenty of water for 15 to 20 minutes.</li> <li>• Call a poison control centre or doctor for treatment advice.</li> </ul>
If inhaled	<ul style="list-style-type: none"> <li>• Move person to fresh air.</li> <li>• If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.</li> <li>• Call a poison control centre or doctor for further treatment advice.</li> </ul>

**TOXICOLOGICAL INFORMATION:**

No specific antidote is available. Treat symptomatically.

**DIRECTIONS FOR USE:**

To be used only for the manufacturing, formulating or repackaging of a plant growth regulator which is registered under the *Pest Control Products Act*.

STORAGE

Store in original tightly closed container. Do not ship or store near food, feed, seed and fertilizers. Store in a cool, dry, locked, well-ventilated area without floor drain.

DISPOSAL

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial regulations. For additional details and clean-up of spills, contact the manufacturer and the provincial regulatory agency.
