DIRECTIONS FOR USE:

Use Restrictions:

DO NOT apply to any body of water.

Avoid application of this product when winds are gusty.

DO NOT apply directly to freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs, and wetlands), estuaries or marine habitats.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wash water.

DO NOT allow spray mixture to stand for more than 18 hours.

DO NOT apply in greenhouses.

DO NOT apply by any type of irrigation system.

Restricted-Entry Interval:

Do not allow people or pets to re-enter treated areas until sprays have dried.

Pre-harvest Interval (PHI): Magic GardenerTM Caterpillar Killer can be applied up to and including the day of harvest. PHI=0 days.

Mixing: Partially fill spray tank with water and provide moderate agitation. Add the required amount of Magic GardenerTM Caterpillar Killer while maintaining agitation. Add remaining water, if any. Mix until Magic GardenerTM Caterpillar Killer is fully dissolved in water. Maintain moderate agitation while loading and spraying.

Do not mix more Magic GardenerTM Caterpillar Killer than can be used in a 12-hour period.

Application: Spray mixture thoroughly onto both the top and bottoms of leaves. Apply at first sign of infestation and repeat every 3 to 14 days depending on rain, pest activity and plant growth rate.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

ENVIRONMENTAL PRECAUTIONS:

To reduce runoff from treated areas into aquatic habitats, avoid application to areas with a moderate to steep slope, compacted soil or clay. Avoid application when heavy rain is forecast. Contamination of aquatic areas as a result of runoff may be reduced by including a vegetative filter strip between the treated area and the edge of the water body.

STORAGE:

Magic Gardener[™] Caterpillar Killer should be used within 36 months from the date of manufacture when stored at 0 to 25°C. Store this product away from food or feed. Store in original container. Store upright and keep tightly closed when not in use.

DISPOSAL: Do not reuse the empty container. Dispose in household garbage. Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
