DIRECTIONS FOR USE

To be used only in the manufacture of a product which is registered under the Pest Control Products Act.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Hazard to humans. Corrosive – causes irreversible eye damage and skin burns. Do not get in eyes or on skin. Harmful if swallowed. Avoid breathing dust. During mixing/loading or formulating of the concentrate wear a long-sleeved shirt, long-legged pants (or coveralls), chemical resistant apron, chemical resistant gloves, chemical resistant shoes, shoe covers, or boots, and goggles or face shield. Wash thoroughly after handling. Remove contaminated clothing and wash before reuse.

FIRST AID PROCEDURES

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

STORAGE

Store in a cool, dry place away from any source of puncture. Store in original container. Avoid storage near water supplies, food or feed to avoid contamination.

SPILL CLEAN-UP

Keep bystanders away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (coveralls, rubber boots and protective gloves). Absorb the liquid onto soil, sawdust or other suitable absorbent material and shovel into a drum. Add broken packages to the drum and seal for removal to an approved disposal site. Wash spill site with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower and wash thoroughly with soap and water on completion of mopping up operation. For details on spill cleaning, contact the Provincial Regulatory Agency or the manufacturer.

DISPOSAL

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial regulations. For additional details and clean up of spills, contact the manufacturer and the provincial regulatory agency.
