## **DIRECTIONS FOR USE**

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Weight per tablet: xx g

Maintain recommended daily levels as determined by testing kit.

Free Available Chlorine: 1.0 - 3.0 ppm

pH: 7.2 - 7.8

Total Alkalinity: 100 – 120 ppm

Calcium Hardness: 200 – 300 ppm

For outdoor pools, chlorine residuals can be protected from destruction by the sun's rays by adding 300 g of stabilizer [cyanuric acid] per 10,000 L of pool water to yield the required initial concentration of 30 ppm.

If using an automatic chlorinator, fill the chamber[s] with **INNOVAQUA INNOVA ZINC** and adjust flow rate according to manufacturer's recommendations to maintain proper chlorine residual. Adding tablets to the pool's skimmer basket is an alternative chlorine feed method. Daily usage should approximate 25 g of **INNOVAQUA INNOVA ZINC** per 10,000 L of pool water.

NOTE: Hot weather, heavy pool usage, and rain may require higher usage rates to maintain proper chlorine residuals.

Periodic superchlorination of pool water is recommended. Follow label instructions of superchlorination product being employed.

**INNOVAQUA INNOVA ZINC** contains a stabilizer which can accumulate in pool water. Keep stabilizer within the range of 30-100 ppm by dilution with fresh water.

#### WARNING

Direct tablet contact may cause bleaching of vinyl or painted pool surfaces.

Automatic feeding devices employing these tablets must be totally free from traces of other pool sanitizers to avoid the probability of an explosion.

#### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

Dangerous gas formed when mixed with acid. Do not mix with any other chemical. Strong oxidizing agent. May cause fire or explosion if contaminated. It is recommended wearing rubber gloves when handling this product. Avoid contact with skin and eyes. Avoid breathing dust. Harmful if swallowed. Keep container closed and store in a cool, dry location.

## **FIRST AID**

**If swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
