PRECAUTIONS KEEP OUT OF REACH OF CHILDREN PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Avoid contact with eyes, skin and clothing. Harmful if swallowed or absorbed through the skin. Do not inhale dust or vapours. Causes eye irritation. May cause dermal sensitization. Wear long-sleeved shirt, long pants, goggles or face shield and chemical resistant gloves when handling. Wash well after handling and before eating, drinking or smoking. FIRST AID

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

TOXICOLOGICAL INFORMATION

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

AGRICULTURAL CHEMICAL

Do not ship or store with food, feeds, drugs or clothing.

ENVIRONMENTAL PRECAUTIONS

Toxic to aquatic organisms.
