PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes, skin, or clothing. Avoid inhaling the product. Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes during loading, application, clean-up and repair. Wash hands thoroughly with soap and water after handling and before eating, drinking, and chewing gum or chewing tobacco. DO NOT enter or allow people or pets to enter treated areas until dusts have settled.

FIRST AID:

If swallowed:

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 - 20 minutes. Call a poison control centre or doctor for treatment advice.

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If in eyes:

Hold eye open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DIRECTIONS FOR USE

As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

Post-Emergent Control: Apply at a rate of 15-40 g/m². The standard rate for this product is 25 g/m². Reapply after 3-4 weeks for best results. See table below for application rate to control specific weed species.

<u>**Pre-Emergent Control (Crabgrass)**</u>: Apply when soil temperatures reach 10–15 $^{\circ}$ C at 40 g/m² to control emergence of smooth crangrass and suppress emergence of large crabgrass. Reapply after 3 – 6 weeks for best results.

How to Apply:

Contents may have settled during shipment; invert bag several times to ensure product is mixed.

One kg of product will treat between 25 and 67 m² (269 - 721 ft²). For best results, apply a few days after mowing when temperature is between 10°C and 30°C. If temperature is below 27°C, ensure turf is wet from dew, or water turf lightly before application. If temperature is above 27°C, do not pre-wet grass and apply product in the late

afternoon or evening. Do not exceed the 15 g/m² rate when temperature is above 30°C. Do not apply when daytime temperature exceeds 32°C.

Apply using a broadcast/rotary, drop, or handheld spreader calibrated according to the manufacturer's directions. Uniform coverage is important to prevent turf damage. Turf areas can be re-sown one day after treatment. Apply product only on turf. Application on hard surfaces can cause staining. If product gets on surface, sweep off if the surface is dry, rinse off immediately if the surface is wet. If product gets on clothing or footwear, wash immediately.

Visible signs of control may be seen within 24 hours after application. Susceptible weeds will turn brown or black. Occasionally a darkening of the grass leaf blades can occur after treatment however, the grass will recover within a few days to several weeks. May stain thatch (dead grass under turf); this does not affect the health of the grass. If turf is damaged, irrigation 24 hours after application, followed by mowing to remove any turf tip burn, can promote faster recovery.

Use Precautions:

-Do not apply to drought stressed grass; ensure that the turf is well watered prior to application.

-Do not apply when daytime temperature is above 32°C.

-Do not apply in windy conditions.

-Do not apply to bentgrass. If unsure of grass sensitivity, test apply to a small area of turf.

-Apply this product only to turf, and sweep any product that lands on the driveway, sidewalk or street back onto the treated area.

-Avoid contact with desirable plants. Any desirable plants or structures accidentally contacted should be rinsed immediately with water.

-Do not apply if rainfall is expected within 24 hours of application.

-Do not irrigate within 24 hours of application.

STORAGE: Store this product away from food or feed.

DISPOSAL

1. Thoroughly empty the contents of the container into the application device.

2. Follow provincial/territorial instruction for any required additional cleaning of the container prior to its disposal.

- 3. Make the empty container unsuitable for further use.
