DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed.

May be fatal if inhaled

Do not inhale vapours.

May cause eye or skin irritation. Avoid contact with eyes, skin and clothing.

Wash well after handling and before eating, drinking and/or smoking. Wash contaminated clothing with soap and hot water before re-use. Do not wear contaminated shoes.

FIRST AID

IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

Keep in original container during storage.

Store product in cool, dry, well-ventilated place away from seed and fertilizer.

Keep away from heat or open flame, or other sources of heat.

DISPOSAL

For spills, wear appropriate safety equipment. Absorb spilled product with inert substance such as sawdust or sand. Wash spill area with a detergent solution.

If involved in fire, use water, foam, CO₂ or a dry chemical extinguishing media. Noxious fumes may be produced under fire conditions; wear self-contained breathing apparatus.

Prevent water used in fire-fighting from entering public water supplies.
