GENERAL INFORMATION

Tide Plant Guard was developed to maximize the effectiveness of post emergence herbicides

DIRECTIONS FOR USE

Tide Plant Guard may be used as recommended on this product label. Check the pesticide label for specific crop use, and timing of application.

APPLICATION RATES

Apply at a rate of 0.50% v/v (5L Tide Plant Guard /1000 L spray mixture). When applied as a tank-mix combination, read and observe all label directions, including rates, personal protective equipment, restrictions and precautions for each product used in the tank mix. Always use in accordance with the most restrictive label restrictions and precautions.

MIXING INSTRUCTIONS

SHAKE WELL BEFORE USING. Always add Tide Plant Guard adjuvant to the spray mix last and continue agitation or follow specific tank filling and mixing information provided on the herbicide label.

DIRECTIONS FOR USE

The rate of Tide Plant Guard is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes, skin or clothing. Do not get in eyes, on skin, or on clothing. Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes during mixing, loading, application, clean-up and repair. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

FIRST AID
