PRECAUTIONS

1. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
2. Harmful if inhaled. Avoid inhaling or breathing dust.
3. Avoid contact with eyes, skin and clothing. Wash with soap and water after handling, and before eating, drinking or smoking. Wash contaminated clothing before re-use. Do not wear contaminated shoes.

FIRST AID

If on skin or clothing, take off contaminated clothing. Rinse skin **IMMEDIATELY** with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
