DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the **PEST CONTROL PRODUCTS ACT**.

PRECAUTIONS:

PREVENT ACCESS UNAUTHORIZED PERSONNEL.

Harmful in contact with skin and if swallowed. Irritating to eyes. Wear protective gloves and face shield when handling. Remove any contaminated clothing immediately. Wash hands and exposed skin thoroughly after handling. Avoid breathing dust.

FIRST AID:**IF SWALLOWED:**

Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED:

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Treat symptomatically.

SPILLAGE CLEAN-UP:

Keep bystanders away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves), and sweep up all product and shovel into a drum. Dampen spilled product and use absorbent sweeping compound to prevent dust. Add broken packages to the drum and seal for removal to an approved disposal site.

Wash spill site with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment. Shower and wash thoroughly with soap and water on completion of mopping up operation.

DISPOSAL:

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial/territorial regulations. For additional details and clean up of spills, contact the manufacturer and the provincial/territorial regulatory agency

STORAGE:

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer or other pesticides. Keep away from fire or open flame or other sources of heat.
