GENERAL INFORMATION

SHOO Garlic Mosquito Repellant-D is a dilutable concentrated garlic solution that is sprayed on plants, shrubs, turf, outdoor structures as well as over event environments prior to the events to repel mosquitoes. Mosquitoes are repelled almost immediately after spraying. A temporary garlic scent may be noticeable in the treated area following application.

DIRECTIONS FOR USE: 900 mL treats up to 280 sq. metres (3000 sq. ft.). Shake well before using.

GARDEN HOSE END SPRAYER: Connect to garden hose, turn sprayer valve to “On” and use 900mL of product per 280 sq. metres (3000 sq. ft.). Spray until run-off.

MANUAL PUMP, ELECTRIC OR COMPRESSED AIR SPRAYER: Use at 80 mL/L dilution and use entire 900mL concentrate bottle over 280 sq. metres (3000 sq. ft.) Spray until run-off.

For best results spray in early morning or early evening when wind is down. Spray on and under the leaves of bushes, trees, hedges and shrubs, gardens, grass, buildings, walls, structures and under decks. Spray 10 metres (33 feet) into long grass. Re-apply when mosquitoes return or after heavy rain.

DO NOT APPLY TO PETS. Pet hair which contacts treated surface may have an odour for a few days. Garlic oil may cause marking of some plants or surfaces. Apply to small area or individual plants to determine compatibility.

Do not apply to any body of water.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN

Do not swallow. Avoid contact with eyes. May cause eye irritation. Inhalation may cause respiratory irritation. Apply only when the potential for drift is minimal. Individuals who are sensitive or allergic to garlic or soy should avoid handling **SHOO** Garlic Mosquito Repellant-D. Individuals who are sensitive or allergic to garlic or soy should avoid treated areas until dry or after a heavy rain.

FIRST AID

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

To prevent contamination store this product in sealed containers. Store in cool, dry, well-ventilated area not to exceed 50°C. Prevent from freezing. Store this product away from food or feed.

DISPOSAL

DO NOT reuse the empty containers. Dispose in household garbage.

Unused or partially used products should be disposed at provincially or municipally designated hazardous waste disposal sites.
