#### **PRECAUTIONS**

#### **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

## **TOXICOLOGICAL INFORMATION**

Treat symptomatically.

#### **STORAGE**

DO NOT contaminate water, food and feed by storage, cleaning of equipment or disposal. Keep in original container during storage. Keep container tightly closed.

# **DISPOSAL**

Completely empty container by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into formulation equipment.

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal and provincial regulations. For additional details and clean-up of spills, contact the manufacturer and the provincial regulatory agency.
