PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Strictly observe all precautions for handling and using pesticides. May irritate eyes. May irritate skin. Potential skin sensitizer. Avoid contact with skin, eyes and clothing. Wear protective goggles when handling. **DO NOT** wear contact lenses while handling. Use of an approved pesticide respirator is recommended. FIRST AID:

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control centre or doctor for further treatment advice.

TOXICOLOGICAL INFORMATION:

There is no specific antidote. If this product is ingested, treat symptomatically.

ENVIRONMENTAL PRECAUTIONS:

TOXIC to aquatic organisms.

STORAGE:

Store product in the original container. Keep out of the reach of children and animals. DO NOT contaminate water, food or feed by storage. If freezing occurs, place the container in a warm room (18°C or above) and allow product to thaw. Roll or shake container frequently until thawing is complete.
