GENERAL INFORMATION

Doktor Doom Go Green Garlic Mosquito Repellent for Yards & More is a dilutable concentrated garlic solution that may be sprayed on plants, shrubs, turf, outdoor structures, and prior to events, to repel mosquitoes. Mosquitoes are repelled by Doktor Doom Go Green Garlic Mosquito Repellent for Yards & More almost immediately after spraying. A temporary garlic odour may be noticeable in the treated area following application.

DIRECTIONS FOR USE

Shake well before using. 900 mL treats up to 280 sq. metres (3000 sq. ft.).

Garden hose: Set dial at low-medium range & use entire 900 mL per 280 sq. metres (3000 sq. ft.).

Pump Sprayer: Use at 80 mL/L dilution and use entire 900mL concentrate bottle per 280 sq. metres (3000 sq. ft.).

Spray until run-off. For best results spray in early morning or early evening when wind is down. Spray under the leaves of bushes, trees, hedges and shrubs, gardens, grass, buildings, walls, structures and under decks. Spray 10 metres (33 feet) into long grass. Reapply when mosquitoes return or after heavy rain. **DO NOT APPLY TO PETS.** Pet hair which contacts treated surface may have an odour for a few days. Garlic oil may cause marking of some plants or surfaces. Apply to small area or individual plants to determine compatibility.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN Do not swallow. Avoid getting on skin and in eyes. May cause skin and eye irritation. Avoid inhaling/breathing mist or vapours. Potential skin sensitizer. Apply only when the potential for drift is minimal. Individuals who are sensitive or allergic to garlic should avoid handling this product. Individuals who are sensitive or allergic to garlic should avoid treated areas until dry or after a heavy rain. Applicators and handlers must wear long sleeved shirt, long pants, water-proof gloves, shoes plus socks and protective eyewear.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Treat symptomatically.

STORAGE

To prevent contamination, store this product in heated, ventilated area. Store this product away from food or feed. Prevent from freezing.

DISPOSAL

FOR DISPOSABLE CONTAINERS

1. Triple or pressure-rinse the empty container. Add the rinsing to the spray mixture in the tank.
2. Follow provincial/territorial instruction for any required additional cleaning of the container prior to its disposal.
3. Make the container unsuitable for further use.
4. Dispose of the container in accordance with provincial/territorial requirements.

FOR REFILLABLE CONTAINERS:

For disposal, this empty container may be returned to the point of purchase (distributor/dealer). It must be re-filled by the distributor/dealer with the same product. Do not reuse this container for any other purpose.
