## FIRST AID

## **DIRECTIONS FOR USE**

**CROPS:** Spring Wheat and Barley

**VIKING RSA F2 Adjuvant** is to be used only with VIKING Pinoxaden Herbicide or VIKING Pinoxaden F2 Herbicide. Apply at a rate of 0.7 litres per hectare (0.7 L/ha).

Refer to the VIKING Pinoxaden Herbicide or VIKING Pinoxaden F2 Herbicide label for further details on mixing instructions.
