PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN, PETS AND LIVESTOCK.

May irritate eyes and skin. Avoid contact with eyes and skin. Store away from food or feed. Do not store in areas accessible to children, pets and domestic animals.

FIRST AID:

HUMAN:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

PET:

If swallowed: If pet poisoning is suspected, immediately contact a veterinarian.

TOXICOLOGICAL INFORMATION:

HUMAN: Treat symptomatically.

PET: Chocolate consumption can be harmful to dogs: Seek immediate treatment should vomiting, diarrhea or other signs of toxicosis occur after any substantial consumption of lure. 50 g of lure contains 16 mg of methylxanthine.

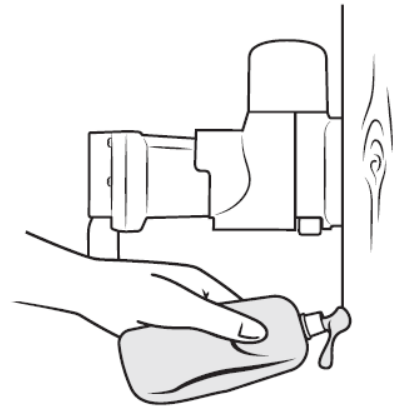
This product acts solely as an attractant to draw Rats and Mice to the A24 Rat & Mouse Trap. It is to be used with A24 Rat & Mouse Trap for indoor and outdoor management of rats and mice.

USE LIMITATIONS:

Do not use in areas accessible to children, pets, and domestic animals.

INSTRUCTIONS FOR USE:

To attract rats and mice: When visiting your trap, smear a thumbnail-sized dollop in the area around your trap. Re-apply this lure as it is consumed or if it is spoiled. To increase the attractiveness of this lure, all alternative food sources should be removed or made unavailable to rats and mice as much as possible. Application of this lure may result in staining of the application site surface.



RETAIN PACKAGING INFORMATION FOR FUTURE REFERENCE

STORAGE: Store at temperatures between 0°C and 15°C once opened. Store container upright and keep tightly closed when not in use.

DISPOSAL: Clean containers can be recycled
