**PRECAUTIONS**  
**KEEP OUT OF REACH OF CHILDREN**  
**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Avoid contact with eyes, skin and clothing. Harmful if swallowed or absorbed through the skin. Do not inhale dust or vapours. May cause dermal sensitization. **FIRST AID**

**Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**TOXICOLOGICAL INFORMATION**

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

**AGRICULTURAL CHEMICAL**

Do not ship or store with food, feeds, drugs or clothing.

**ENVIRONMENTAL PRECAUTIONS**

Toxic to aquatic organisms.
