## **DIRECTIONS FOR USE**

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*

## **FIRST AID**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

## **PRECAUTIONS**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Causes moderate eye irritation. Harmful or fatal if swallowed. Harmful if absorbed through skin or inhaled. Avoid contact with skin, eyes or clothing. Avoid breathing vapour. Remove contaminated clothing and wash before reuse. Wash thoroughly with soap and water after handling. Potential skin sensitizer.
