**INDOOR USE:** For spot treatment in industrial plants, manufacturing plants, warehouses, meat packing plants, food processing plants. Crack and crevice treatment in ship holds, railroad boxcars, industrial plants, manufacturing plants, warehouses, meat packaging plants and food processing plants.

**OUTDOOR USE:** Spray localized areas on outside surfaces of industrial plants, manufacturing plants, warehouses, meat packing plants, food processing plants.

**DIRECTIONS:** Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will flow into cracks and crevices for insect control. Keep off treated areas until spray is dry. If reinfestation occurs, repeat applications. Provide adequate ventilation after indoor use.

In meat and food processing plants treat only when plant is NOT in operation. Remove or cover all food packaging materials, and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored.

Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. Do not spray near flame or spark. Do not puncture or incinerate. Harmful if swallowed, inhaled or absorbed through skin or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. Do not use in food preparation, serving or storage areas.
