**INSTITUTIONAL - INDUSTRIAL**

**DISINFECTION:** 5mL (1/200) per litre of water, to disinfect hard non porous surfaces. For difficult to clean surfaces or in contagious disease areas, use 6mL (1/10) to a litre.

**FOGGING SICKROOMS:** (When unoccupied) use 16mL (1/60) to a litre.

**SURGICAL INSTRUMENTS:** Immerse in a solution of 6mL (1/160) to a litre for 10 minutes.

**DISHES AND UTENSILS:** Use 3mL (1/320) to a litre, immerse in solution and rinse.

**FOOD PLANTS AND DAIRIES:** Scrub equipment using a solution of 3mL (1/320) to a litre and rinse. On difficult to clean surface, such as: meat cutting boards, increase strength to 6mL (1/160) to a litre. Surfaces subject to direct contact with food should be thoroughly rinsed with potable water. Do not mix with soap or anionic detergent. Do not store in food processing or storage areas.

**PRECAUTIONS:** Do not get in eyes, on skin or on clothing. Harmful if swallowed. Avoid contamination of food. Protect eyes and skin when handling concentrate.

**FIRST AID:** In case of contact, immediately flush eyes or skin with water for at least 15 minutes and call a physician. Remove and wash contaminated clothing before reuse.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if not available, drink large quantities of water. Never give anything by mouth to an unconscious person. Call a physician.

**TOXICOLOGY:** Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
