DIRECTIONS FOR USE:

This product is for use only with injection tube and for injecting into cracks and crevices where insects may be hiding, living and breeding. Place injector tip 2 cm into cracks, crevices, holes and other small openings where insects may be a problem. Release approx. 1 second spray per spot in serious infestation, if possible, place spots approx. 30 cm apart. In light infestation or preventive treatment place spots approx. 1 metre apart. See the additional directions below for effective control of specified insects.

CRAWLING INSECTS: Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders, and Ticks: Spray into hiding places such as cracks and crevices, moist areas, openings around pipes and sinks, behind baseboards, metre boxes and manholes. Spray directly on insects in these locations where possible.

Silverfish: Spray cracks and crevices in baseboards, door frames, bookcases and storage areas. Spray directly on insects in these locations where possible.

Ants: Spray into trails, nests and points of entry around doors, windows, structural cracks and crevices. Spray directly on insects in these locations where possible.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin, clothing and avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking, etc. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact. In food processing and meat packing plants, use only when plant is not in operation. Remove or cover all food, food processing equipment, packaging materials and utensils before application. After application, wash as surfaces that may contact food and rinse with potable water before reuse for food processing. Do not use in rooms where milk is processed, handled, or stored. **DO NOT CONTAMINATE FOODSTUFFS.** Do not use in any areas where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored. In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that may contact food before reuse. **CONTENTS UNDER PRESSURE.** Do not puncture or incinerate container. Do not use or store near heat or open flame or spark. Exposure to temperatures above 50°C may cause bursting. Do not spray on plastic, painted or varnished surfaces or directly into any electronic equipment such as radios, televisions, computers, etc. Do not use as a space spray.

STORAGE: Keep product in cool and dry place, away from open flames and heat sources.

DISPOSAL: When container is empty, press valve to release all remaining pressure. Dispose of empty container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.

FIRST AID INSTRUCTIONS: Product contains petroleum distillate. If swallowed, do not induce vomiting and seek medical attention at once or call poison control centre. In case of contact with eyes or skin, flush with water. If irritation persists, seek medical attention.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. Obtain medical attention immediately, taking the pesticide container with you.
