#### PRECAUTIONS

Repeat ipecac dose if unsuccessful within 20 minutes. Continue with water until vomit is clear. Patient should be lying down with the head below the level of feet while vomiting. Use the scoop to measure 50 g. When starting with an empty planter, place enough treated seed in the planter box to cover the bottom. Treat this seed in a separate container that later can be destroyed. Add the remaining seed to the planter box and treat by thoroughly stirring with a paddle or lath so that the seed is coated with the seed treatment.
