DIRECTIONS FOR USE

COOLING WATER SYSTEMS: Bacteria Control: Initial dose 20-80 mL per 1000 L of water in total system. Maintenance Dose: Every 1-5 days or as needed 4-80 mL per 1000 L of water in system. For bacteria control in industrial water supply systems treat 4-80 mL per 1000 L of water entering system. Note: Product should not be used in water intended for drinking or food preparation.

PRECAUTION KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Severely irritating to the eyes and may cause eye damage. Workmen handling the product should wear rubber gloves and goggles and should avoid contact of the product with clothing and skin.
