Apply this dust to dry foliage when insects or damages first appear, at 7-10 day intervals. Obtain complete coverage; use lower rates for younger plants. Apply when potato plants are 5-10 cm high. Injury may occur if applied when the leaves are tender or wet, or in extended periods of high humidity.

HOW TO USE: Use 25-50 g per 10 m² to control Colorado Beetle, Early & Late Blight, European Corn Borer, Leafhopper, Potato Flea Beetle, Tomato Fruitworm, Tomato Hornworm. For Fall Armyworm, use lower rates. This application will also control Anthracnose, Grey Mold and Leaf Spot on Tomato.

For Stinkbugs: Use 50-60 g per 10 m^2 .

For Climbing Cutworm: Use 30-40 g per 10 m of row applied in 25-30 cm band over row.

LIMITATIONS: Do not apply within 7 days of harvest. Do not feed crop refuse to animals.
