General Information

Floralife Formula D.C.D. is an effective antimicrobial cleaner designed for use by wholesale and retail florists, shippers and greenhouses. When used as directed, Floralife Formula D.C.D. will disinfect hard, nonporous surfaces such as flower buckets, floors and walls of coolers, design and packing benches, and countertops. It may be relied on to deodorize coolers, buckets, garbage pails and other areas where obnoxious odors may develop.

This product may be used as a general purpose antimicrobial detergent in florist shops, wholesale florists, shippers, greenhouse packing areas and other commercial floriculture places where efficient cleaning and antimicrobial action against certain bacteria and fungi including *Pseudomonas fluorescens*, *Erwinia herbicola* and *Saccharomyces cerevisiae*, which cause:

1. Plugging of stems with slime which reduces uptake of water for various flowers including roses, chrysanthemums, gladioli and tulips.
2. Production of ethylene gas which may injure blooms of the various sensitive flowers including carnations, snapdragons, some orchids, baby's breath, sweet peas, freesia and alstroemeria.

DIRECTIONS FOR USE

General Classification

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For Cleaning

Lightly soiled areas — surfaces to be cleaned should be mopped or brushed with a solution containing 8 mL of Floralife Formula D.C.D. per litre of water. Rinse cleaned area with fresh water.

Heavily soiled areas — mop or brush soiled surface with a solution containing 16-24 mL of Floralife Formula D.C.D. per litre of water. Rinse cleaned surface with fresh water.

Disinfection

(Control of bacteria and fungi which cause effects as outlined under "General Information"). To disinfect flower buckets, walls and floors of coolers and other hard, nonporous surfaces in retail and wholesale florists, shippers and greenhouse packing areas. Mop or brush surface to be treated with a solution containing 8 mL of Floralife Formula D.C.D. per litre of water. Surfaces to be disinfected should be maintained thoroughly wet with the use solution for ten (10) minutes. All soiled surfaces are to be precleaned prior to disinfection, according to the directions for cleaning. Solution used for disinfection is not to be reused.

Deodorization

Prior to deodorization of flower buckets, garbage pails, coolers and other areas where obnoxious odors may develop, remove all leaves, petals, garbage and refuse. Preclean surfaces using pressurized water where possible before deodorization. To deodorize, mop or brush surfaces thoroughly with a solution containing 60 mL of Floralife Formula D.C.D. per litre of water.
