DIRECTIONS: To control wasps, hornets, bees and yellow jackets.

1. Shake can well before using. 2. Remove protective cap. 3.

Insert plastic tube into spray nozzle. 4. Direct the tube at the target insect nest. 5. Press the nozzle and from a distance of 2-2.5 metres (6-8 feet) completely cover the nest with foam. The insects will now be trapped in the nest. 6. Insert the applicator wand into the nest opening and fill the nest with insecticide foam. Allow sufficient time for insects to become inactive before destroying the nest. Application to nests should be made in late evening or early morning when insects are at rest. LIMITATIONS:
