FIRST AID

If a known exposure occurs or is suspected, immediately initiate the recommended procedures below. If further treatment is required, contact a Poison Control Centre, a physician, or the nearest hospital.

If Swallowed: Immediately give several glasses of water and induce vomiting by gagging the victim with a finger or blunt object placed on the back of the victim's tongue. Give fluids until vomitus is clear. If victim is unconscious, do not induce vomiting or give anything by mouth.

If Inhaled: Remove to fresh air. Seek medical attention if respiratory irritation occurs or if breathing becomes difficult.

STORAGE

Store in a cool dry well ventilated area away from foodstuffs and out of reach of children and animals. Protect from excessive heat. This product is not affected by freezing.

SPILL CLEANUP

Wear Appropriate protective equipment (gloves, glasses, apron) when attempting to clean up the spill. If the container is leaking, secure leak and place the container into a drum or heavy gauge plastic bag. Contact ZENECA Agro (See EMERGENCY NUMBER) for further information.

For spills and leaks; clean up as much of the product as possible with a broom and shovel. If available, use an absorbent such as DUSTBANE to clean the spill area. Shovel the spilled product and spend absorbent in sealable waste container.

On hard surfaces - sprinkle spill area with detergent and scrub in a small quantity of water with a coarse broom. Let stand for 10 minutes then absorb onto an inert material and shovel waste into a waste container.

On soil - remove the top 15 cm of soil in the spill area and replace with fresh soil. Dispose of all waste including scrub brush in accordance with provincial requirements. For more information on the disposal of waste and the clean up of spills, contact the provincial regulatory agency or the manufacturer.

DISPOSAL

Rinse the empty container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the provincial regulatory agency or the manufacturer.

DIRECTIONS FOR USE

GENERAL USE PRECAUTIONS

Use only for claims listed and only as specified on this label. Folpet 50-WP may be combined with most commonly used insecticides, adjuvants and fungicides. Fungicidal activity is reduced if combined with strongly alkaline materials. This material should not be used in combination with or closely following oil sprays.

Do not apply or allow to drift to areas occupied by unprotected humans or beneficial animals or onto adjoining food, fiber of pasture crops. The grower is responsible for damages caused by drift from his property to that of others.

Consult local agricultural authorities for additional information, as the timing of applications needed will vary with the local conditions.

APPLICATION RATES

Ornamentals

Unless otherwise specified, dosage rates are in terms of Folpet 50-WP per 1,000 litres of water. Thorough coverage is required.

Asters, Phlox: Powdery Mildew - Use 2 kg. Make first application before disease appears and repeat at 7 to 10 day

intervals. Increase frequency during periods of rapid new growth and severe infection caused by rains or high humidity.

Azaleas (Cuttings): Damping Off - Use 1.5 to 2 kg. Soak cuttings for 15 to 30 minutes before planting in rooting media.

Carnations: Alternaria Leaf Spot - Use 2 kg. Make first application 2 weeks after planting and treat 3 to 4 times at bi-weekly intervals.

Chrysanthemums: Powdery Mildew, Septoria Leaf Spot - Use 2 kg. Make first application immediately after planting and repeat at 7 to 10 day intervals. Increase frequency during periods of rapid new growth and severe infection caused by rains or high humidity.

Iris: Didymellina Leaf Spot - Use 2 kg. Make first application when plants emerge and repeat at 7 to 10 day intervals.

Marigolds, Zinnias: Alternaria Leaf Spot - Use 2 kg. Make first application when plants emerge and repeat at 3 to 7 day intervals. Use the higher frequency during periods of rapid new growth and severe infection caused by rains or high humidity.

Poinsettias (Greenhouse): Pythium, Root Rot - Use 2 kg plus a spreader and use 600 ml of suspension per 20 centimetre pan. Make application at time of panning and repeat 10 days later.

Roses: Black Spot, Powdery Mildew - Use 2 kg. Make first application when first leaves unfold and repeat at 7 to 10 day intervals throughout the season. Do not use wetting agents on roses as injury may result.

Snapdragons: Anthracnose, Powdery Mildew - Use 2 kg. Make first application when plants emerge and repeat at 3 to 7 day intervals. Use the higher frequency during periods of rapid new growth and severe infection caused by rains or high humidity.
