DIRECTIONS FOR USE

Proper application of RAISIO 973 depends on many factors, such as system design and severity of the problem. This product is to be used in accordance with control procedures established by a RAISIO Technical Representative for a specific system. The use rate ranges between 50 to 250 grams per tonne of pulp or paper produced. Not for use in the production of paper or paperboard that comes into contact with food.

May cause delayed chemical burns. Causes eye and skin irritation.
