**DIRECTIONS:** SHAKE WELL BEFORE USING. Hold can upright while spraying.

**TO KILL HOUSE PESTS:**

**Flying Insects:** Flies, Mosquitoes, Wasps, Biting Midges and Flying Moths. Close doors and windows. Direct mist upwards in sweeping motion to all parts of the room especially windows and other light sources. Apply 6-10 seconds burst per **30m<sup>3</sup>** of space. Whenever possible, keep doors and windows closed for 15 minutes after each treatment. Also direct mist into areas where insects are present. Keep spray at least 1 m from interior wall, fabrics

and furniture.

**Crawling Insects:** Cockroaches, Spiders, Crickets, Ants, Carpet Beetles, Centipedes & Silverfish. Spray hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray ant trails, around door sills, window frames, or in ant nests. Insects must be hit to be killed.

**Bed Bugs:** Spray mattress lightly, particularly around seams and tufts. Take beds apart, spray bed frame and springs including all joints. Repeat as required.

**Pests on Ornamental Plants:** For control of Aphids, Two-spotted Spider Mites and Adult White Flies on the following plants: African Violets, Aralia, Christmas Cherry, Chrysanthemum, Cineraria, Dieffenbachia, Fuschia, Gloxinia, Ivy, Lantana, Neathe Bella Palm, Petunia, Rose & Snapdragon. Spray when insects are noticed with a slow sweeping motion so that mist drifts on upper and lower leaf surface. Use caution on new growth and tender foliage. Repeat as necessary.

#### **TO KILL GARDEN PESTS: ON FLOWERS AND ORNAMENTALS.**

**Sucking Insects:** Exposed Thrips, Leaf-hoppers, Spotted Mites, Lacebugs, Aphids.

**Chewing Insects:** Caterpillars, Climbing Cutworms, Japanese Beetles, Tent Caterpillars, Canker Worms & Garden Webworms on Ornamental Crabapple, Cherries & Plum Tree. For insects on Asters, Azaleas, Begonias, Chrysanthemums, Dahlias, Delphiniums, Gladiolas, Irises, Marigolds, Petunias, Roses, and Snapdragons, Evergreens, small Deciduous trees, shrubs and vines: Carefully spray with slow sweeping motion keeping 30 cm to 45 cm away from the plants to avoid wetting the foliage. A light spray kills pests effectively. Spray only when air is still and temperature is under 32°C. Do not spray in direct sunlight - early morning or evening preferred. Use with caution on young plants and new growth. Insects must be contacted by spray to be killed.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Cover fish bowls and remove pets for one hour when spraying rooms. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying. Avoid contact with skin, eyes, clothing. Avoid inhalation of spray. Wash after using. Keep from freezing. Do not use on Maiden Hair ferns. Do not use on vegetable crops.

**DISPOSAL:** When container is empty, press button to release all pressure then dispose in household garbage. Do not puncture or incinerate.

**FIRST AID:** In case of contact, with eyes or skin, flush with water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once or call poison control centre. .
