DIRECTIONS FOR USE: For control of bacteria and fungal slime in industrial recirculating cooling water systems and recirculating process water scrubber systems, add 40-200 mg/L once a week based on system's volume. If contamination is excessive, use 200-400 mg/L until the system cleans up. Feed directly into the cooling or process system's water where it will be uniformly mixed. Do not apply to potable water supply. Use PVC, stainless steel or polyethylene feeding equipment.
