DIRECTIONS FOR USE:

Timber-Life Wood Preserver is a highly effective, ready-to-use solution that protects wood, rope or fabric against rot, mildew and termites. Use above or below ground. This product also increases the life of your wood.

ECONOMICAL: One litre treats 2 - 9 m² of wood, or 2 - 4 m² of 240 g duck, or 4 - 7 kg of rope.

USE EXACTLY AS RECEIVED: When treating wood, make sure surface is clean and dry. Remove all paint, varnish, wax or any other coating that may impede penetration. No thinning is necessary.

APPLY BY BRUSH ONLY: Do not spray or dip. Apply as much solution as will readily soak up. The effectiveness of the preservative is determined by the penetration, so apply liberally. One coat is usually sufficient, but two coats are desirable if rotting conditions are severe. Allow to dry thoroughly before recoating or painting over. Use with caution with some paint coatings as bleeding may occur.

ON ROPE: Brush solution on liberally depending on the diameter of the rope. Allow 12 hours for drying before use.

ON FABRIC: Use only on exterior industrial fabric, duck cloth, awnings, etc. Saturate with a swab, brush or sponge. Drain and allow to dry before using. Do not use on fabric or wood where prolonged skin contact may occur. Do not use on rubber-lined fabric.

PRECAUTIONS:

Flammable - do not use near open flame or spark. Avoid breathing vapours. Harmful if swallowed or inhaled - may cause skin irritation. Wash thoroughly after use and before eating or smoking. Keep treated material away from food, animals and drinking water. May be used for material for greenhouses and non-food producing plants. Phytotoxicity may be prevented by allowing carrier solvent to dry thoroughly. KEEP OUT OF REACH OF CHILDREN. Keep containers closed when not in use. Do not contaminate bodies of water. This product is toxic to fish.

TOXICOLOGY:

Contains petroleum distillate and copper naphthenate. Treat as for ingestion of kerosene.

FIRST AID:

In case of skin contact, wash immediately with soap and water. If splashed in eyes, flush with plenty of water and obtain medical attention. If swallowed, get medical attention immediately - do not induce vomiting.

DISPOSAL AND STORAGE:

Do not re-empty containers but dispose them in household trash. Store unused product away from children and animals. Do not store in areas of excessive heat.
