DIRECTIONS

Before using ABF-42, industrial and commercial cooling tower systems must be cleaned to remove existing algae growth, bacterial slimes, and other deposits. Then apply an initial dose of 5 to 12.5 litres of ABF-42 per 10,000 litres of recirculating water to provide a concentration of 500 to 1,250 ppm of ABF-42. Repeat this initial dose until control is evident. Subsequent doses of 1.25 to 12.5 litres of ABF-42 (125 to 1,250 ppm of ABF-42) per 10,000 litres of water in the system, should be applied every 2 to 5 days or as needed. The frequency of dosage depends upon the relative rate of bleedoff and the severity of the microbiological contamination. The dosages should be introduced into the tower sump.

PRECAUTIONS: Harmful if swallowed. Avoid contact with the skin and eyes. Avoid contamination of food.
