DIRECTIONS

Sanex Mosquito Fog is a ready-to-use solution. For most effective treatment apply as a dense fog close to the ground. The best time to fog is early morning or late evening when air speed is less than 8 km/h. Apply at the rate of 150-200 mL of Sanex Mosquito Fog Insecticide per 100 square metres of area. Lay down fog in 5 meter swaths allowing the slight ground wind to carry the material to the areas where mosquitoes are present. Fog in the direction of a breeze while moving away allowing the fog to drift into infested areas, contacting as many insects as possible. Allow the fog to dissipate before re-occupying the treated area. Repeat treatment as necessary. When using a thermal fog generator, the equipment must be operated and maintained in the manner prescribed in the instructions given in

the manufacturer's manual.

PRECAUTIONS

Avoid inhaling fog. Operator should wear face mask. Avoid contact with skin, eyes and clothing. Avoid contamination of ponds, lakes, streams, and other bodies of water which contain fish life or which may be used for irrigation or domestic purposes. Toxic to wildlife.
