DIRECTIONS FOR USE

To be used only in the manufacture of a herbicide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND/OR PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Avoid contact with skin, eyes, or clothing. Avoid breathing vapour or dust. May be harmful if swallowed. May cause irritation to eyes and skin. Ensure good ventilation. When handling, wear protective clothing and equipment including a respirator, goggles or safety glasses, and chemical resistant gloves. Wash hands and exposed skin after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Do not contaminate water, food, or feed by storage or disposal.

FIRST AID:

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN/CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.

GENERAL: Never give anything by mouth to an unconscious person. Remove person to a safe and uncontaminated area. Seek medical attention immediately if [toxicity/irritation/etc.] persists or is severe. Have the product container or label with you when calling a poison control centre or doctor, or going for treatment.

TOXICOLOGICAL INFORMATION:

Medical Personnel should contact Bayer's Medical Information Services, Toll-Free: 1-800-334-7577. Primary routes of entry are skin absorption and dust inhalation. Treatment should be supportive.

STORAGE:

Keep in original container. Store closed container in a cool, dry place away from water, feed, seeds, or foodstuffs.
