DIRECTIONS: PRO-3 ULV CONCENTRATE INSECTICIDE is recommended for use in homes, restaurants, food processing plants, warehouses, and industrial installations, to control cockroaches, granary insects, granary weevil, rice weevil, confused flour beetles, red flour beetles, meal moths, cadelles, grain mites, saw-tooth grain beetles, flies, mosquitoes, small flying moths and gnats.

Space Spraying for Flying Insects: ULV Applicators: Apply at the

rate of 100 mL of PRO-3 per 100 m<sup>3</sup> of space. Decrease application rate for larger areas to as little as 100 mL/100 m<sup>3</sup>.

Ordinary Mechanical Fogging Equipment: PRO-3 can be used diluted in equipment such as a microsols, Fogmaster or atomist. Dilute PRO-3 with base oil at the rate of 1 part concentrate plus 29 parts of oil and mix well. Apply at the rate of 200 mL diluted spray per 100 m<sup>3</sup> of space. If the whole building is to be fogged or misted, all personnel with the exception of the operator must be evacuated from the premises. Ventilating systems must be shut down. All switches operating any electrical equipment which might function during misting/fogging must be turned off. All fires, flames and pilot lights or other sources of ignition must be extinguished and safely shut off. Cover all exposed food processing equipment before spraying, fogging or misting. In food processing plants, meat packaging plants and food service establishments, apply only when plant is in operation. Remove all food, meat products, ingredients or packaging materials from the room. Spray upwards to all parts of the room especially windows, light sources and other areas where insects are present. Spray only when temperature is less than 32°C. Keep area sealed for at least 30 minutes after each treatment. Do not remain in treated area. Ventilate the building for at least 30 minutes before re-entry. Following ventilation, clean up dead insects. All treated surfaces that may contact meat, food products or other food products should be washed and rinsed thoroughly with potable water after treatment and before reuse for food processing.

Use as a Contact Spray: Dilute PRO-3 with base oil at the rate of 1 part concentrate plus 29 parts of oil and mix well. Apply with a sprayer that gives large, spray particles. Spray outside walls of grain bins, flooring, about base of milling machinery, walls and baseboards, areas behind cabinets, around pipes and other insect harbourages using 5L of sprayer per 100 m<sup>2</sup> of surface. Force spray into all cracks and crevices. Repeat applications as necessary. Note: Keep product away from fire, open flame, lighted electric bulbs, and other sources of heat. Do not use this oil based spray on tiled floor surfaces or rubber backed rugs. Do not spray varnished or plastic surfaces. Toxic to fish. Avoid contamination of food, feed and water supplies. In food processing plants and food service establishments, apply only when plant is NOT in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation. For meat packing plants, treat only when plant is NOT in operation. No exposed meat products, ingredients or packaging materials should

be kept in the room. Cover food handling equipment. All treated surfaces that may contact meat or other food products should be washed and rinsed thoroughly with potable water after treatment and before reuse for food processing.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND ANIMALS. PRODUCT CONTAINS PETROLEUM DISTILLATE. Do not store, pour, or use near open flame. Harmful if swallowed, inhaled or absorbed through skin. Avoid inhalation of spray. Wear mask or respirator when applying spray mist. Wear protective clothing. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after use. Keep container closed and store in a cool place.

FIRST-AID: For skin contact, wash with soap and water. If in eyes, flush with plenty of water for at least 15 minutes. DANGER: THIS PRODUCT CONTAINS PETROLEUM DISTILLATES. If swallowed, DO NOT induce vomiting. If patient is unconscious, give him air. Obtain medical attention or call poison control centre immediately.

TOXICOLOGICAL INFORMATION: Treatment for the various reactions is symptomatic.

DISPOSAL: Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.
