4. Place 3-4 coils about 3 metres apart-around areas to be protected. (1 coil per 28 cubic metres). **DISPOSAL:** Do not reuse empty containers. Wrap and dispose in household garbage.

1. Each set consists of two coils.
2. Hold the slotted end of one of the two coils, shake lightly and coils will separate.
3. Bend the centre of the metal stand to upright position.
4. Insert the slot of the coil into the top of the stand.
5. Light outer end of the coil with a match.
6. A broken piece may be used by inserting it into the open gap of the metal stand.
