DIRECTIONS:

Add separately to system. Do NOT mix with other chemicals. Introduce through chemical pump/tank or feeder leading to recirculating line or direct to sump. Apply at an initial rate of 120 ppm to total water holding capacity of the system. This dose may be repeated once, twice or three times weekly or as required to control the growth of slime-forming organisms. When microbial control is evident, apply at a maintenance rate of 20 to 40 ppm every three days or as needed.

PRECAUTIONS:
