PRECAUTIONS

DIRECTIONS FOR USE

1. Initial dosage for pool water having no visible algae is 170 mL of Algae Kill per 10,000 L of pool water.
2. Weekly maintenance dosage is 60 mL per 10,000 L.
3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 250 mL of Algae Kill per 10,000 L.
