DIRECTIONS FOR USE

MUSHROOMS:

To control the PHORID FLY and SCIARID FLY inside the mushroom house after filling and during production, apply this dust on the beds as soon as possible (a few hours) after picking, at the rate of 375 g/100 m<sup>2</sup> of bed surface. Make applications about once a week when Phorid and Sciarid flies are actually present. Do not

apply within 48 hours of picking. For further details follow the Ontario Mushroom Pesticide Recommendations.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid breathing dust, wear a respirator. Avoid contact with skin and eyes. Wash thoroughly after use. Avoid contamination of food, feed, ponds, streams and lakes.

FIRST AID:

If swallowed, induce vomiting, repeat until fluid is clear. Rush patient to nearest hospital taking this labelled container with you. In case of skin contact, remove contaminated clothing and wash skin with soap and water. If in eyes, flush with plenty of water for 15 minutes and go to the nearest hospital at once.

TOXICOLOGICAL INFORMATION:

Malathion may cause cholinesterase inhibition. Atropine is antidotal; 2-PAM may be administered in conjunction with atropine.

DISPOSAL:

1. Empty the bag.
2. Follow provincial instructions for any required additional cleaning of the bag prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environment Canada.

STORAGE:

Store in a cool, dry place away from food, feed and seed.
