DIRECTION:

Spray infested surfaces only until wet. Point spray away from people, plants, and pets. Do not apply as a space spray.

For use in non-food areas only. Do not apply in edible product areas of food processing plants. Treat food processing plants early in the season before canning or other processing begins. Repeat applications, if necessary, when plant is not in operation. Remove any exposed food products, equipment or packaging material before spraying. Rinse all equipment with water before resuming operations.

COCKROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS: Spray heavily in all cracks around baseboards, and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks and stoves. Use on other localized areas infested with these pests. Repeat treatment as necessary. Do not spray foodstuffs or house plants.

FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS: For wasps apply the spray directly to the nest. Treat at night, or early morning when the insects are inside. For outdoor use only as an aid in reducing the annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate.

FLEAS, ANTS AND BROWN DOG TICKS: For treatment of localized infestations of these insects on outdoor areas where there is no vegetation, spray infested area thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as necessary.

For fleas and brown dog ticks apply as a coarse wet spray to sleeping quarters of pets and areas around base boards, windows and doorframes, all cracks and localized floor. Repeat as necessary. After spraying, place fresh bedding in animal quarters. Do not spray animals.

Application of this product in home should be limited to spot treatment only.

Avoid excessive wetting of plastic, rubber, and asphalt surfaces such as tiles and coverings.

Do not store, handle or use near fire, open flames or sparks. Do not smoke while spraying. Harmful if swallowed, inhaled or

absorbed through skin. Avoid contamination of feed and foodstuffs. Do not apply to the edible products areas of food processing plants. Avoid breathing of spray mist and provide adequate ventilation of areas being treated. Avoid contact with skin, eyes or clothing. Wash thoroughly after using. Do not use on household pets or humans. Do not allow children in treated areas until surfaces dry. Remove pets and cover fish bowls before spraying. If dizziness, headaches or nausea occurs, visit a physician taking this label with you.
