DIRECTIONS FOR USE: TIMBERLIFE Copper-Based End Cut Wood Preserver is a highly effective, ready to use solution for all cuts, holes and injuries to pressure treated lumber. Two coats meets CAN/CSA Standards 080.15-M89 for end cuts on pressure treated wood.

USE EXACTLY AS RECEIVED: Do not dilute. If field cutting or drilling is unavoidable, use exactly as received. Apply by brush only. Do not spray or dip. Ensure all wood surfaces are clean and dry. Remove all paint, varnish, wax or other coating that

may impede penetration. No thinning is necessary. Apply as much solution as will readily soak up. One coat is usually sufficient but two coats are desirable if rotting conditions are severe. Allow to dry thoroughly before recoating, or painting over. Use caution with some paint finishes as some bleeding may occur.

PRECAUTIONS: Do not use or store near open flame or spark. Avoid breathing vapours. Harmful if swallowed or inhaled. Avoid skin contact - may cause skin irritation. Wash thoroughly with soap and water after use and before eating, drinking or smoking. When applying this product wear appropriate protective clothing and rubber or plastic gloves. Keep treated material away from food, animals and drinking water. May be used for green house material and garden timbers in contact with non food producing plants only. Phytotoxicity may be prevented by allowing carrier solvent to dry thoroughly before introducing plants. Keep out of reach of children. Keep containers closed when not in use. Do not contaminate bodies of water. This product is toxic to fish.

TOXICOLOGY: Contains petroleum distillate and copper naphthenate. Treat as for ingestion of kerosene.

FIRST AID: In case of skin contact, wash immediately with hand degreaser or vegetable oil and then with soap and water. If splashed in eyes, flush with clean water for 15 minutes and obtain medical attention. If swallowed, get medical attention immediately - do not induce vomiting.

DISPOSAL AND STORAGE: Do not re-use empty container. Dispose of empty containers in household trash. Store unused product away from children and animals. Do not store in areas of excessive heat.
