DIRECTIONS FOR USE OF BAIT TRAYS:

- Do not remove from box until ready to use.
- Prior to use, remove all sources of food such as crumbs, sugar, syrup and grease spots.
- Snap trays out of plastic frame.
- Remove facing from adhesive pad on the underside of each bait tray and affix each tray to a dry surface.
- For maximum effectiveness, be sure to use all 12 trays at once.
- Use 12 trays to treat approximately 20 sq. metres (215 sq.

- feet).
- Place where roaches have been seen: as under sinks, refrigerators, cabinets, pipes, baseboards and in pantries (NON-FOOD).
 - Place majority of trays in kitchen (NON-FOOD areas only), bathroom and pantries (NON-FOOD).
 - Never place in wide open areas - always where roaches travel, as along edges where walls meet ceiling and floors especially near warm, damp areas and cracks and crevices.
 - Roaches will feed and generally die in their hiding places.
 - After using for 7-10 days the roach population will decrease.
 - Replace trays when necessary (e.g. every 2-3 months) with fresh trays for continued effective control.
 - Disposal - wrap trays and put in garbage cans.
 - Do not contaminate water with improper disposal.
 - Place bait trays in areas not accessible to children and discard used trays in garbage.

PRECAUTIONS:

- KEEP OUT OF REACH OF CHILDREN AND PETS.
- Place bait trays in areas not accessible to children and pets.
- Do not remove bait from trays.
- May be harmful if swallowed.

READ DIRECTIONS BEFORE USING

- A. Snap trays out of plastic frame.
- B. Use all 12 trays at once for the most effective results - clean all areas of food sources.
- C. Place trays with printing up.
- D. For maximum results, the trays must be placed at key locations - where roaches travel, feed and live. Generally in warm, dark, damp places and where food is available - such areas are usually the kitchen, bathroom, pantries (NON-FOOD), basement, cabinets, shelving, closets, under appliances, drawers, dropped ceilings, water pipes, radiator pipes, cracked plaster walls and loose moldings.
- E. Recommended locations for trays.
 1. Garbage can areas - on floor - on walls.
 2. Under sink - kitchen and bathrooms - near pipes.
 3. Under stove and behind stove or in storage space of stove.
 4. Kitchens & pantries (NON-FOOD) - on shelves - place along walls and corners.
 5. Refrigerator - under and near drip pan.
 6. Behind toilets near pipes entering toilet.
 7. Dishwasher - place on floor close to washer and near pipes leading to washer.
 8. Microwave - place behind oven.
 9. Closets - place on floors and shelves in corner.

10. Appliances - place behind wall clock - light fixture -stereo
- T.V. etc.
11. Place near or in loose cracks and behind loose moldings.

HOW IT WORKS:

After feeding on bait, most roaches will die within 7-10 days in areas usually not visible. In some cases where heavy infestation exists it may take a month or more to achieve desired results. Additional trays should be used if heavy infestation exists.

Fresh bait trays should be used every 2-3 months for continuing effective control.
