AMINO-PROPHYL is an algicide, fungicide disinfectant based on quaternary ammonium compounds for bathing areas. AMINO-PROPHYL is very effective for athlete's foot alongside swimming pools, in

showers, steambaths and change-rooms.

#### DIRECTIONS FOR USE

FOR USE IN A LOW-PRESSURE PRODUCT APPLICATION SYSTEM: To disinfect, use AMINO-PROPHYL in concentration of 1% or 10 mL per litre (1 1/2 oz per gallon) of water. Use on surfaces which have already been cleaned. Allow to stand for 15 minutes. This application method is particularly suited for use in showers.

MANUAL APPLICATION: To disinfect, use AMINO-PROPHYL in concentration of 1% or 10 mL per litre (1 1/2 oz per gallon) of water. To avoid creating suds, simply pour AMINO-PROPHYL into water, rather than adding water to AMINO-PROPHYL. Solution may be applied with a brush or a cloth.

#### PRECAUTION

AMINO-PROPHYL pure may cause skin irritation or damage to the eyes. Harmful if swallowed. Avoid contact with the skin and the eyes. Do not drink. Avoid contamination with food. AMINO-PROPHYL should never be used in presence of soap or anionic detergent. Rinse empty container thoroughly with water and throw away. Keep out of reach of children.

#### FIRST AID TREATMENT

In case of contact, immediately flush the eyes or the skin with a lot of water. For the eyes, call a physician. If swallowed, drink promptly a large quantity of milk, white of eggs, a gelatin solution, or, if these are not available, drink a lot of water. Avoid alcohol. Call a physician immediately. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

#### TOXICOLOGICAL INFORMATION

This product is toxic to fishes.

#### DISPOSAL

1. Triple or pressure-rinse the empty container. Add the rinsing to the treatment site.
