food, remove edibles, utensils, and wrappings before application. Thoroughly scrub with detergent and rinse with potable water before replacing foodstuffs or utensils.

BATHROOM: Solution cleans, disinfects, and deodorizes bathtubs, shower stalls, and sinks. To clean and disinfect toilet bowls, flush, then add 16 mL of concentrated product.

DIAPERS: Soak soiled diapers in solution. Reduces odor and aids laundering.

SICK ROOM: Use solution as a pretreatment for normal washing of bedding, linens and towels. Use solution on environmental surfaces, utensils, and furniture. Rinse well.

MISCELLANEOUS USES: Solution will reduce odors, remove grease and grime, reduce wax buildup, disinfect, and perform other hard cleaning jobs. Use all through your home.
